Motion by Joycelyn Ninham to pay bills. Second by Ira Cornelius. Motion carried.



Motion by Ira Cornelius to adopt the resolution in reference to Mutual Help
Housing. Second by Joycelyn Ninham. Motion carried.

Motion by Ira Cornelius to adopt resolution authorizing Housing Authority
and Oneida Tribe to enter into agreement with Kelloggs Citizens National
Bank and Housing Assistance Administration for the amount of \$156,000.00
to finance Mutual Help Housing Project Wis. 10-2 for a period of at least
one(1) year at which time the Housing Assistance Administration will pur-
chase the finished homes under the Turn Key Process and that the Tribe
further authorizes the Oneida Housing Authority to enter into agreement with
the Great Lakes Inter-Tribal Council GAP Program for 20 trainees to be paid
through O.E.O. under M.D. T. A. policy to build project Wis. 10-2.
Second by Joycelyn Ninham. Motion Carried.

Motion by Ira Cornelius to authorize Tribal Council to sign any further
documents concerning Mutual Help Housing Wis. 10-2. Second by Joycelyn
Ninham. Motion carried.
