Motion by Oscar Archiquette to adopt the Oneida Loan Agreement pursuant to a resolution of March 30, 1967. Second by Joycelyn Ninham. Motion carried.

Minutes read. Motion by Joycelyn Ninham to accept the minutes as read. Second by Oscar Archiquette. Second and carried.

John Reed would like an assignment. Referred to Artly Skenandore.

Mrs. Irene Moore inquired about lease for land. She would like the same as last year.

Motion by Oscar Archiquette to accept the lease of land to Irene Moore for 1(one) year to be the same as last year (which calls for 1/2 payable in advance). Second by Ira Cornelius. Motion carried.

Ruth Baird announced the survey to be made on and around Onida by the Employment Office to find the need for employment.

Motion by Joycelyn Ninham to place Mrs. Artly Skenandore in charge of the Intertribal dinner on May 20, 1967 for the Oneida Tribal Council. Second by Oscar Archiquette. Motion carried.

Motion by Oscar Archiquette to accept the application for land assignment for Vernon Duxtator on the old Amos Christjohn assignment. To be held in abeyance until release is signed. Second by Joycelyn Ninham. Motion Carried.

Mrs. Irene Moore asked for people to volunteer to bring food for the Youth Conference to be held on May 6, at the Methodist Hall.

Motion by Oscar Archiquette to accept the application of land assignment by William L. Reed be approved. Second by Joycelyn Ninham. Motion carried.
