Continued Meeting
September 7, 1967

The meeting was called to order by Chrm. Purcell Powless at 8 p.m. at the Episcopal Parish Hall.

Council members present: Chrm. Purcell Powless, Vice Chrm. Oscar Archiquette, Sec. Loretta Ellis, Treas. Joycelyn Ninham.

Guest present were Ernest Smith, CAP Committee Chrm., and Vista Volunteers Miki Beane and Phil Kyle.

Chrm. Powless read letter from Mr. Riley in regard to term of office for Ernest Smith. Motion by Oscar Archiquette to re-appoint Mr. Smith to Oneida Housing Commission. Second by Joycelyn Ninham. Motion carried. Ernest Smith accepted appointment retroactive to April 21, 1967 for 4 year term.

Chrm. Powless read letter from BIA in regard to unallotted trust fund balance of \$350.70 in Treasury of the United States.

Chrm. Powless read letter about tourism from Charles S. Domon from Window Rock, Arizona, Box 54. It was agreed to acknowledge letter to inform him we are not interested at this time.

Letter read to Mr. LaRoche, BIA, Great Lakes Agency from Commissioner Robert L. Bennett.

It was agreed to call Mr. E.J. Riley and set up a new date for scheduled meeting with him and Stockbridge-Munsee Council.

Mr. Al Johnson VISTA director for this area will be here September 14th at 2 p.m. The Tribal Executive Council, CAP coordinator and the VISTA will then meet with Mr. Johnson at 8 p.m. in the library. The purpose of this meeting will be to draw up a workable VISTA program for the coming year.

Motion by Oscar Archiquette that letter opposing Custer series by Attorney Hinkfuss be approved. Second by Joycelyn Ninham. Motion carried.

Oscar Archiquette suggest Hinkfuss and Johnson letter be sent to NCAI office in Denver, Colorado.

Motion by Oscar Archiquette to continue meeting to September 11th. Second by Loretta Ellis. Motion carried.
