

Continued meeting  
September 11, 1967

Name of Tribe – Oneida Tribe of Indians

The meeting was called to order by Chrm. Purcell Powless at 8 p.m. at Oneida Memorial Park.

Council members present: Chrm. Purcell Powless, Vice Chrm. Oscar Archiquette, Sec. Loretta Ellis, Treas. Joycelyn Ninham

Motion by Joycelyn Ninham to close continued meeting. Second by Loretta Ellis. Motion carried.

Minutes read and approved.

Moton by Loretta Ellis to accept same as read. Second by Joycelyn Ninham. Motion carried.

Joycelyn Ninham suggest small investigation and an answer to Menominee Trails, Inc. by 15 September. Loretta Ellis is to contact Rosa Hill to compete as Princess; also to contact Oscar Archiquette on Oneida singers. Irene Moore is to contact Mrs. Tom Schuyler on bead work.

Irene Moore asks if Tribe has been approached by Wisconsin Public Service Co. for surveying of Government land for installation of poles.

Discussion held with Sylvester F. Cornelius on status of 9 acres of redeemed land he resides on. Copy of grant to be issued to Mr. Cornelius.

Robert Danforth is to be notified to attend next monthly meeting and make application for standard land assignment. See Artley Skenandore on the matter.

Irene Moore accepts appointment for Chairman of Education Committee.

Oscar Archiquette suggest three appointments for Credit Committee be made between this meeting and next monthly meeting.

Discussion held on grandchildren of Violet Vieaux. Matter already taken care of.

Joycelyn Ninham will inform Robert Stevens that their child is not eligible for enrollment.

Discussion on workable program. It is urgent that program be drawn up and submitted immediately. Chrm. Powless appoints Woodrow Webster as Chrm. of Workable Program. Loretta Ellis is to notify Mr. Webster.

Motion by Loretta Ellis that application for standard land assignment of Cornell J. Skenandore be approved. Second by Joycelyn Ninham. Motion carried.

Motion by Oscar Archiquette that application for standard land assignment of Vernon D. Doxtator be approved but reduced from 5 acres to 2 ½ acres. Second by Joycelyn Ninham. Motion carried.

Motion by Oscar Archiquette that Richard K. Smith's application for standard land assignment be tabled. Second by Loretta Ellis. Motion carried.

Motion by Oscar Archiquette that Mr. Artley Skenandore be paid for services on filling out applications for standard land assignments. Second by Loretta Ellis. Motion carried.

Motion by Oscar Archiquette that all bills be paid including 18 birth certificates. Second by Joycelyn Ninham. Motion carried.

Motion by Oscar Archiquette that application for standard land assignment of Nicholas Jourdan be approved. Second by Joycelyn Ninham. Motion carried.

Discussion held on possible trip to National Congress of American Indians convention in Portland, October 2-6, 1967. Motion by Oscar Archiquette that Loretta Ellis be sent as delegate to Portland, Oregon and if sponsorship is available from some outside source, Joycelyn Ninham be sent also. Second by Joycelyn Ninham. Motion carried. Loretta Ellis is to contact Mr. William Byler, Executive Director of Association on American Indians Affairs, Inc. on the matter.

Discussion held on sending delegate to Pow-Wow preparations at Wausau on Saturday, 16 September. It was decided to send Oscar Archiquette, even though the Executive Council was not properly informed.

Motion by Oscar Archiquette that same tract of 12 acres (9tillable) be leased to Mrs. Simon Moore. Second by Oscar Archiquette. Motion carried.

Discussion held on the matter that took place during terms of office of Chrm. Hill and Vice Chrm. Lee McLester. Mr. and Mrs. Cornelius Baird had an approved tribal loan of \$500.00 The drew out only \$125.00 They are not paying on the principle. However, the

interest is up to date. Motion by Loretta Ellis that balance of \$375.00 of loan for Mr. and Mrs. Cornelius Baird be cancelled. Second by Oscar Archiquette. Motion carried.

OEC Mutual Help Housing Program explained by Mr. Steve Quida from the OEC program office in Washington, D.C.

Motion by Joycelyn Ninham that birth certificates be accepted. Second by Loretta Ellis. Motion carried.
