Present: Chrm. Purcell Powless, Vice Chairman Irene Moore, Sec. Amelia Cornelius,
Treas. Joycelyn Ninham.

The meeting was called to order at 7:40 p.m.

Minutes read for Feb. 3, 10, 17, 24, 25, 1969.

Motion by Joycelyn Ninham to accept minutes as read. Second and carried.

Treasurer report read:

Amelia Cornelius made a motion to accept treasurer report. Second and carried.

Wm. Danforth inquired about the availability of the Tom Schuyler assignment. Informed him to attend the meeting on March 8 for more information.

Irene Moore made a motion to pay annuity to Marion M. Doxtator, MRs. Beulah L. Jessepe, Thomas Metoxen, Mrs. Ethel Mae Powless, Mrs. Margaret E. Stowe, Walter Webster and Marie Cardinal. Second Joycelyn Ninham, motion carried.

Joycelyn Ninham made a motion to accept the relinquishment of Mary Alice Gorman Martinez and her daughter Lori Denise Martinez. Second by Irene Moore, motion carried.

Irene Moore made a motion to send rejection notice to Gerald Ray Denny on behalf of his minor children that they are not eligible for enrollment in the Oneida Tribe because they don't have enough blood quantum, must be $\frac{1}{4}$ to be enrolled. Second by Joycelyn Ninham, motion carried.

Joycelyn Ninham made a motion to pay bills, second and carried.

Moycelyn Ninham made a motion to reject the family members of the William Smith family who do not have enough Oneida blood for enrollment. Second by Irene Moore, motion carried.

Motion by Irene Moore to authorize secretary write to assemblyman Rogers to support changes in the scholarship program for Indian students. Second by Joycelyn Ninham. Motion carried.

Also instructed the secretary to write to Laird and Byrnes in support of Bennet and find out if he is going to be reinstated as commissioner.

VISTA discussed the problems of the Youth Club. Decided to discontinue until after Easter.

ICAP representative Loretta Ellis discussed with the Council about the assembly she and Oscar Archiquette are putting on for the West DePere High School. Also the United Community Council would like to start a program for high school youth.

Amelia Cornelius made a motion to appoint Loretta Ellis and Evelyn Smith on the Educational Committee. Second by Irene Moore, motion carried.

Decided to meet on Sat. March 15, 1969 a Special General Tribal meeting for discussion on the purchase price of the Chicago Corners school building.

Motion to adjourn until later date. Second and carried.
