The meeting convened at 7:30 p.m.

Report by Mr. Hinkfuss on the Lester Skenandore assignment.

Industrial Park report that shares will soon be for sale at \$5.00 per share to Oneida members. Resignation of Wendell McLester accepted.

Irene Moore made a motion to accept the covenant for right of way of Industrial Park and to have Mr. Hinkfuss forward to BIA for approval. Ira Cornelius second, motion carried.

Mr. Folz from the Welfare Dept. gave the requirements for eligibility for welfare recipients, medical assistance, Old age assistance, blind aid and ADC.

He suggested a letter from the Council requesting a meeting with the welfare board might be useful.

Mr. Arnold Brown from the Rhinelander Public Health Services gave a report on his office and services.

Mr. Don Densmore and Mr. Clarence Ray also gave a report on their services.

Joycelyn Ninham made a motion to authorize the Housing Authority to take care of any merchantable timber on the CCC Cap. Second by Irene Moore, motion carried.

Norbert Hill made a motion to delegate the responsibility of the truck to the Housing Authority. Seconded by Joycelyn Ninham, motion carried.

Norbert Hill made a motion to have Dean Sickles explore the possibility of commercial Housing on Mrs. Margaret Summers redeemed land near the golf course. Second by Joycelyn Ninham, motion carried.

Amelia Cornelius made a motion to accept resignation of Joycelyn Ninham, seconded by Irene Moore, motion carried.

Joycelyn Ninham made a motion to appoint Alma Webster as the Interim Treasurer until the July semi-annual meeting. Second by Irene Moore, motion carried.

Joycelyin Ninham made a motion to pay bills, seconded by Irene Moore, motion carried.

Norbert Hill made a motion to adopt resolution 70-03 to extend the attorney s contract for an additional 5 years with Aaron, Aaron, Shimberg and Hess. Second by Irene Moore, motion carried.

Irene Moore made a motion to endorse the Project Media Development for Handicapped Youth. Second by Norbert Hill, motion carried.

Motion by Norbert Hill to table further action on the Merlin Cornelius application for land lease. Seconded by Joycelyn Ninham, motion carried.

Ira Cornelius made a motion to table Robert Schuyler's application for homesite lease until next month. Second by Joycelyn Ninham, motion carried.

Job opening for Tutoring Project Supervisor.

Irene Moore made a motion to post the job description. Second by Ira Cornelius, motion carried.

Job opening for Assistant Director for CAP program in Bowler.

Norbert Hill made a motion that the Council should adopt a resolution urging GLITC to institute a ICAP in Wis. Second by Irene Moore, motion carried.

It was decided to have the BIA check into the Lewis Summers Estate for possible exchange of land with Airport.

Motion to adjourn, second and carried.
