Amelia Cornelius moved to deposit HUD money in the Seymour Bank when it arrives. Seconded by Ira Cornelius. Motion carried.

Gordon McLester suggested to Myron Smith that he organize a Junior Tribal Council.

Norbert Hill moved to apply for retroversion of law and order on Oneida Tribal lands. Seconded by Gordon McLester. Motion carried.

Gordon McLester moved to refrain from selection of CHR until after the posting date of March 31. Seconded by Judy Barton. Motion carried.

Norbert Hill moved to adopt a resolution to have the BIA establish a BIA sub-agency to be locate at Oneida. Seconded by Amelia Cornelius. Motion carried.

Norbert Hill moved to adopt the concept of the Standing Rock Program for the Oneida Tribe. Seconded by Gordon McLester. Motion carried.

Gordon McLester moved to adjourn. Seconded and carried.
