Special meeting - Law enforcement

Special meeting of the Oneida Tribal Business Committee was called
to order.

Gordon McLester gave a report on the background of the proposal,
"Specialized Community Officer Program". In January we had funding
from Emergency Employment Act. At that time a deputy was hired
under E.E.A. This deputy was only in training when he was in an
accident and could not work.

Dan Van De Hey from the Criminal Justice Planning told the Committee
that way back when they started to work on this proposal, they were
working to get 2 persons for both counties, but because of the total
population of the Oneida area, we are allowed only 1. The reason
for the misunderstanding was because we had already hired a person
under E.E.A. so the proposal was thought to be forgotten by the
Business Committee since we had hired someone else. Mr. Van De Hey
suggested that we get one officer in Outagamie county first and
later work on getting one in Brown County

Special Law Enforcement Meeting (cont)

Also that a sub-committee should be formed by the Tribal Council to give direction in hiring this person and later to help the officer. This proposal was passed by the Outagamie Board of Directors

Calvin Spice told Committee the person hired would have to attend Fox Valley Technical School. Under the Minimum Training Standard Law this person has to go to school for 260 hours. While he goes to school he would receive full salary and his schooling is paid for. To have this deputy work in both areas, there would have to be some type of agreement between both counties. Mr. Spice said

could be glad to write to the Attorney General and ask his opinion to waive this so that the deputy could work in both counties

Van De Hey will need a letter stating how the money is being used that was going to be used for the deputy before he got hurt

Van De Hey discussed the changes that should be made in the proposal. Will send by mail.

Robert Hill moved to adopt the proposal. Irene Moore seconded.

Van De Hey was directed to submit the proposal. Motion was carried to accept the proposal "Specialized Community Officer Program" with the new changes.

Irene Moore made a motion to adjourn. Seconded by Gordon McLester
