Loretta Metoxen moved to meet and review the findings of the Investigating Committee with the 5 terminated employees of O.T.D.C. on April 25, 77, at 7 p.m. at the Tribal Building. Motion second by Robert Thomas, motion carried.

Norbert Hill moved to adjourn, second by Loretta Metoxen, Loretta Withdrew second after short discussion on items needing action.

Wendell Mc Lester moved to accept the Health Board recommendation for the 77-78 Health Center budget. Second by Loretta Metoxen, motion carried.

O.H.A. Jean Johnson request for land for 30 units of housing. Discussion. Land site proposal is needed by April 20, 1977. Stan Webster stated that the Land Committee did not want to lease any more land to the Housing Authority. Applications on file with housing for approx. 100 persons.

Amelia Cornelius moved to approve the lease of 10 units of land at Hillside area, 10 units of land at Goose town area, and a portion of land at the Nursing Home site area for the 10 elderly units with the Oneida Housing Authority. Second by Norbert Hill Discussion.

Amelia Cornelius moved to amend motion to add ' that the Oneida Housing Authority commit themselves to seeking alternative sites and to the purchase of land for other units of housing. Second by Norbert Hill, 3 for, 2 oppose (L.M., W.M.) Motion carried.
