ECONOMIC DEVELOPMENT REPORT - BRUCE KING

Bruce gave a report on a possible cigarette site at Highway 29 at county U. This is on the north end of the Oneida Reservation. Bruce had a description of the land and the Building on the land - 6.71 acres. Mark moved to have Bruce continue to work on this project and also have the land committee work with him and Bring Recommendation back to the Business Committee. Tony Seconded Motion carried.

FEASIBILITY STUDY FOR HOTEL- CONVENTION CENTER RESOLUTION

NOW, THEREFORE, BE IT RESOLVED, The oneida Tribe request the Bureau of Indian Affairs to release the unappropriated ITAC funds set aside for Business Development, and

BE IT FURTHER RESOLVED, The Oneida Tribe use the appropriation to conduct studies as outlined in the attached letter specifically a feasibility study costing \$9,995 on a Hotel - Convention center and a feasibility study costing \$1,605 on providing services to the Airport Site.

STEP I STUDY FOR THE ONEIDA VILLAGE AREA RESOLUTION


