### AGREEMENT OF JURISDICTION

"It is further understood and agreed by both parties through this attachment to the 1982 Agreement between the Department and the Tribe that the programs or portions of Programs of Income Maintenance Administration specified under Section VI-A shall be provided under the following jurisdiction: (1) Native American and Non-Native Americans, residing within the boundaries of the Oneida Indian Reservation shall apply for and receive Income Maintenance benefits from the Tribe. (2) Native American and Non-Native Americans residing outside the boundaries of the Oneida Indian Reservation shall apply to the County Department of Social Services in the county in which they reside to receive Income Maintenance benefits. (3) Both the Tribal and County Agency shall subscribe to procedures necessary to prevent case duplications.

The Oneida Tribal Council, through its Department of Social Services, has been officially designated as an Income Maintenance Agency with responsibility to administer Income Maintenance benefits under Section VI-A of this Agreement to families residing within the boundaries of the Oneida Indian Reservation. It is understood by both parties that this agreement is entered into pursuant to the powers enumerated in ss.20.002(13), 46.032, 46.21, 46.22, 49.51, and 49.52, Wis. Stats."

Norbert made a motion to approve the Agreement. Gordon Seconded. Motion Carried.

APPROPRIATION REQUEST FOR INCOME MAINTENANCE

Norbert made a motion to approve the Appropriation Request for Income Maintenance of \$2,307.66 to close out the 1980 contract per audit. Also, \$504.51 is needed to close out 1978-79 Contract. Frank Seconded. Frank opposed. Motion Carried.

Frank had questions on what can be done to stop the over run close-out on these old programs. Loretta and Dick are working to correct these problems.

HEADSTART PROJECT

Frank moved to approve the Headstart Proposal. Norbert Seconded. Motion Carried


