They have requested that our Tribal Attorney, Francis Skenandore, attend a workshop with their Tribal Board of Directors to explain the Oneida plan. The Chippewa Indian Tribe will cover the cost of his expenses. Their attorney will be in contact with Mr. Skenandore to make the necessary arrangements if Oneida has no objections. The Oneida Law Office will follow up on this matter.

The residence is located at 2980 Seminary Road and included is 5.5 acres of land with the residence. The cash price is \$31,000. The Diocese would like to know if the tribe is interested in purchasing this property. They will be considering offers on August 17. To be considered the Tribe has to file an offer to purchase on or before August 17, 1984 with an earnest payment of \$500 and to also have arranged permanent financing to meet the financial commitment at that time.

Lloyd made a motion to request that Carl Rasmussen and Jerry Kurowski inspect the residence at 2988 Seminary Road and give their recommendation to Chris Doxtator where she in turn can make an offer to purchase. Kathy seconded. Motion carried.
