RESOLVED;

That the 2007- 2013 stormwater fees for parcels proven to be USA IN TRUST be cancelled.

BE IT FURTHER RESOLVED; that the 2007 - 2013 stormwater fees for the 42 parcels (EXHIBIT "A" TO THIS RESOLUTION) that were placed in TRUST by the Oneida Tribe of Indians, but have no proof of trust status, shall remain on the roll until proof of trust status is provided by the Oneida Tribe of Indians or the United States.
