Membership Eligibility

Oneida Enrolled Members, Oneida Employees (to include spouse & children), other Tribal Affiliations, and the General Public. We offer a variety of memberships based on type and age.

Category Types

Individual: Gives you access to Oneida Family Fitness programs and services.

Family: Extends benefits to any two adults and children ages 6 months—17 years old that live in the same household.

Initiation Fee

- A one time fee unless your membership has expired for **more than 30 days**.
- Initiation fees do not apply to memberships costing under \$25.00.

Individual: \$25.00 Family: \$50.00

Tribal Enrollment Identification is required upon membership purchase.

Renewal Fee

All members will be provided a renewal rate. The renewal rate shall be extended to members who renew their Annual Membership within 30 days of the original contracted period. A 30- day grace period is granted for payment of your Annual Membership. A membership that is renewed will reflect the original dates contracted at the time of membership originated.

Methods of Payment

Membership fees can be paid by:

1. Cash, Check, VISA, Mastercard, or Discover
2. EFT Draft (Your Checking or Savings account is debited once per month until paid in full).

| Individual | 1 year | \$220.00 | Ages 18 years - 54 |
| Family | 1 year | \$350.00 | Any two adults and children ages 6 months - 17 that live in the same household |
| Individual Elder | 1 year | \$165.00 | Ages 55 + |
| Family Elder | 1 year | \$275.00 | One spouse must be Age 55 + |
| Individual Youth | 1 year | \$82.50 | Ages 6 month - 17 yrs |
| College Student | 1 year | \$165.00 | Full-time status; 25 years and under, I.D. and copy of schedule required, Including High School over 17yrs. |
