BC Resolution 12-11-13-E

Amendments to the Oneida Trust Scholarship Policy

- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States of America, and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS,** the Oneida Business Committee has been delegated the authority of Article IV, Section 1, of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS,** the Oneida Business Committee originally adopted the Oneida Trust Scholarship Policy (Policy) on March 21, 2001, and amendments were made on June 21, 2006 and again on December 30, 2009, and
- WHEREAS,** amendments to the Policy were sought due to ambiguities in the Policy's appeals process, and
- WHEREAS,** the amendments to the Policy include revamping of eligibility requirements, and
- WHEREAS,** the amendments to the Policy also restricts students from receiving funding for a same pre-requisite class, post-graduate preparatory/examination fee or related preparatory course that has already received funding, and
- WHEREAS,** the amendments to the Policy require the Oneida Higher Education Manager to handle appeals, and
- WHEREAS,** additional amendments authorize the Area Manager for Education and Training to make a determination on appeals, and
- WHEREAS,** other minor amendments are being made to update the format to comply with the Legislative Procedures Act and make it more efficient, and
- WHEREAS,** a public meeting on these amendments was held on September 12, 2013 in accordance with the Legislative Procedures Act.

NOW THEREFORE BE IT RESOLVED, that the attached amendments to the Oneida Trust Scholarship Policy are hereby adopted.
