RESOLUTION

## 1-3-77-E

WHEREAS, it is the policy of the Oneida Tribe to eliminate substandard and other inadequate housing, to prevent the spread of slums and blight, and to realize as soon as feasible the goal of a decent home in a sutiable living environment for all; and

WHEREAS, under provisions of the United Staes Housing Act of as amended, the United States of America, acting through the Secretary of Housing and Urban Development is authorized to provice financial assistance ot local public housing agéncies for undertaking and carring out preliminary planning of lowrent housing projects that will assist in meeting this goal;

WHEREAS, the Act provides that there shall be local determination of need for low-rent housing to meet needs not being adequately met by private enterprise and that the Government shall not make any contracts with a public housing agency for preliminary loans for surveys and planning in respect to any low-rent housing projects unless the governing body of the locality involved has by resolution approved the application of the public housing agency for such preliminary loan; and

WHEREAS, the Oneida Tribe of Indians of Wis. approves of the Oneida Housing Authority, a public housing agency, to apply to the Government for a preliminary loan to cover the costs of . survey and planning in connection with the development of 50 turnkey low-rent housing

NOW THEREFORE BE IT RESOLVED that the Oneida Tribe of Indians of Wis. approves the following:

- 1. That there exists in the Oneida Reservation a need for such housing which is not being met by private enterprise;
- 2. That the application of the Local Housing Authority to the Government for a preliminary loan in an amount not to exceed \$25,000 for surveys and planning in connection with low-rent housing projects of not to exceed approximately 50 dwelling units is hereby approved.
