BC RESOLUTION 01-09-13-A CY 2013 County Tribal Law Enforcement Grant – Outagamie County State of Wisconsin/Department of Justice

- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS,** the Oneida Business Committee has been delegated the authority of Article IV, Section 1, of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS,** the Oneida Tribe of Indians of Wisconsin has determined that the overall goal of the Oneida Tribe is to protect, maintain and improve the standard of living and the environment in which the Oneida people live, and
- WHEREAS,** the Oneida Tribe of Indians of Wisconsin established the Oneida Police Department whose mission statement is...*serves the community, within the Oneida Reservation boundaries, by helping build a stronger, safer community through police protection and service while instilling a sense of unity and treating all with respect, dignity and compassion,* and
- WHEREAS,** the Oneida Tribe of Indians of Wisconsin encourages collaborative efforts between the Oneida Police Department and other local law enforcement agencies, such as Outagamie County to continue to provide joint community policing efforts for our community and members, and

NOW THEREFORE BE IT RESOLVED, that the Oneida Tribe of Indians of Wisconsin authorizes and supports the submission of a grant application to the Wisconsin Department of Justice for the CY 2013 County Tribal Law Enforcement grant for an amount up to \$32,075.
