the Oneida General Tribal Council is the governing body WHEREAS, of the Óneida Tribe of Indians of Wisconsin, and

WHEREAS, The Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, Leah S. Dodge-Vasquez, a tribal member and Israel R. Vasquez, a non-tribal member has made application for a long-term lease for residential purposes more particularly described as follows:

The North 287 feet of the East 580 feet of the SE 1/4 NE 1/4 Section 18, Township 23 North, Range 19 East, Outagamie County, Containing 3.82 acres, more or less, subject to all valid existing rights-of-way of record.

NOW, THEREFORE BE IT RESOLVED, by this Committee in Regular session assembled, hereby requests the Superintendent, Great Lakes Agency, to draft a lease in accordance with the Act of August 9, 1955 (69 Stat. 539), as amended, 25 USC 415, for the above described land with a 25-year term which shall automatically and without notice renew for an additional term of 25 years at a total rental of \$1.00 annually, or \$50.00 for fifty years; and

BE IT FURTHER RESOLVED, that the Chairman and Secretary of the Oneida Business Committee are hereby authorized to execute lease documents for and on behalf of the Oneida Tribe of Indians of Wisconsin.
