RESOLUTION # 1-18-95 Y

- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, the Oneida Business Committee has delegated all power to conduct dispute resolution of tribal personnel affairs to the Oneida Appeals Commission under General Tribal Council Resolution <u>8-19-91A</u> and there is no other body at the present time that has been delegated to conduct dispute resolution,
- WHEREAS, the Oneida Appeals Commission can no longer conduct deliberations and make determinations due to a lack of Commissioners who have the requisite training to perform those tasks,
- WHEREAS, the Ordinance regarding filling of vacancies on the Oneida Appeals Commission does not contemplate the particular situation that now confronts the Oneida Appeals Commission,
- WHEREAS, it is in the best interest of the Oneida Nation and the Oneida people to have an operating dispute resolution system that regularly determines issues that bear directly on the public health, safety, and general welfare of the Oneida people,
- AND WHEREAS, the intent of the special appointment procedure section of General Tribal Council Resolution <u>8-19-91A</u> was to provide for the continued ability of the Oneida Appeals Commission to hear and resolve disputes in the event that a vacancy occurred between regularly scheduled elections,

NOW THEREFORE BE IT RESOLVED: That the Oneida Business Committee finds that an

appointment of a qualified Commissioner to the Oneida Appeals Commission at this time is in accordance with the intent of the special appointment procedure section General Tribal Council Resolution <u>8-19-91A</u>,

AND THEREFORE BE IT FURTHER RESOLVED: that the present vacancy on the Oneida Appeals Commission be filled by Mr. Mark Stanchik, until the next regularly scheduled Oneida Appeals Commission election fills the vacancy.
