## RESOLUTION # 1- 25-85-B

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and Treaty Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governmental body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, the Oneida Business Committee, by Ordinance No 1 of April 20, 1963 created and chartered the Oneida Housing Authority, and

WHEREAS, the Oneida Tribe of Indians of Wisconsin owns a parcel of land located in part of Government Lot 23 and part of Government Lot 24, Section 29, Township 24 North, Range 20 East, Oneida Indian Reservation, City of Green Bay, Brown County, Wisconsin, and

WHEREAS, the Oneida Housing Authority requests the Oneida Business Committee to dedicate a parcel of the land to be used for street purposes to the City of Green Bay for access to Housing Project Wis. No. 10-8, and

WHEREAS, the City of Green Bay has agreed to accept the dedication of the parcel of land for street purposes, and


WHEREAS, the legal description of the parcel of land to be dedicated to the City of Green Bay for street purposes is attached hereto and incorporated by reference herein.

NOW, THEREFORE, BE IT RESOLVED that the Oneida Business Committee hereby approves and dedicates the parcel of land herein described to the City of Green Bay, Wisconsin to be used for street purposes for access to the Housing Project Wis. No. 10-8, and requests the Superintendent, Great Lakes Agency, to prepare and recommend approval of the parcel of land dedicated.

BE IT FURTHER RESOLVED that the Tribal Chairman is hereby authorized to execute any and all documents for the parcel of land dedicated to be used for street purposes to the City of Green Bay, Wisconsin for and on behalf of the Oneida Tribe of Indians of Wisconsin.

## STREET DESCRIPTION FOR TRIBAL LANDS

A parcel of land to be used for street purposes and located in part of Government Lot 23 and part of Government Lot 24, Section 29; Township 24 North, Range 20 East, City of Green Bay, Brown County, Wisconsin described as follows:

Commencing at the West One-Quarter corner of said Section 29, thence S 0°-16'-14" W 1,587.21 feet; thence N 89°-48'-54" E 130.00 feet to the point of beginning; thence continuing N 89°-48'-54" E 70.00 feet; thence S 0°-16'-14" W 108.01 feet; thence 18.95 feet along the arc of a 12.00 foot radius curve to the left, the chord of which bears S 44°-57'-26" E 17.04 feet; thence N 89°-48'-54" E 459.08 feet to the West line of West Point Subdivision; thence S 0°-19'-30" W along said West line 70.00 feet; thence S 89°-48'-54" W 541.11 feet; thence N 0°-16'-14" E 190.11 feet to the point of beginning and containing 1.063 acres, more or less.
