RESOLUTION # 1-25-85-D

- WHEREAS, The Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and Treaty Tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the governmental body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, the Oneida Business Committee, by Ordinance No. 1 of April 20, 1963 created and chartered the Oneida Housing Authority, and
- WHEREAS, the Oneida Housing Authority proposes to construct 50 units of housing on the Three Sisters sub-division known as Housing Project Wis. No. 10-8, and
- WHEREAS, the Oneida Housing Authority desires to accept bid proposals for the construction of Housing Project Wis. No. 10-8 under 24 CFR 905.204, the open competition method, and
- WHEREAS, the Indian respondents would be provided preference in the determination of contract award, and
- WHEREAS, the Department of Housing & Urban Development concurs with the Oneida Housing Authority advertisement under the open competition method, 24 CFR 905.204, with the stipulation that the Oneida Business Committee supports the Oneida Housing Authority.
