### **2005 ROAD CONSTRUCTION CONTROL SCHEDULE**

### **ONEIDA NATION-IRR ROAD SYSTEM**

**WHEREAS,** the Oneida Nation of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and

**WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Nation of Wisconsin, and

**WHEREAS,** the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribe Constitution by the Oneida General Council, and

**WHEREAS,** the Oneida Nation, as part of its ongoing process of Transportation Improvement Program Planning, has identified road construction priority projects; and,

**WHEREAS,** the road construction priority projects are identified on the Oneida Nation of Wisconsin 2004 Transportation Improvement Plan / Long Range Transportation Plan submitted by support resolution and accepted by the BIA and,


**WHEREAS,** the Oneida Nation of Wisconsin has identified that implementation of these road construction priority improvements will enhance safety of travel on the Reservation, economic development, housing and the general welfare of the Tribe;

**NOW THEREFORE BE IT RESOLVED:** The Oneida Nation Business Committee does hereby request to receive their Relative Need Percentage in the amount of **\$284,856.30** to conduct IRR construction activities on the Oneida Nation Reservation.

**NOW THEREFORE BE IT FURTHER RESOLVED:** The Oneida Nation Business Committee hereby authorizes its Department of Public Works Director and Transportation Planner and Transportation Engineer to submit Control Schedules on behalf of the Oneida Nation Business Committee.

CERTIFICATION
