### RESOLUTION # 1-31-07-A

#### ***REQUEST TO BE A TRUST ASSET ACCOUNTING MANAGEMENT SYSTEM (TAAMS) PILOT PROJECT FOR THE BIA***


- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS,** the Oneida Business Committee has been delegated the authority of Article IV, Section I of the Oneida Tribal Constitution by the General Tribal Council, and
- WHEREAS,** our Division of Land Management's Land Title & Trust Department had access to the former BIA database (LRIS) Land Records Information System in Aberdeen, South Dakota, provided us with the following reports (A) Informational Title Status Report, (B) Individual Tribal Interest Report, (C) Document Search Report, (D) Tract History Report, and (E) Land Index Report, and
- WHEREAS,** our LT&T Title Examiners were approved with a security check by the BIA and then was assigned a User ID number (assigned by the BIA), and
- WHEREAS,** on December, 2001 our connection to (LRIS) the Aberdeen Title Plant database was shut down due to a pending court case being filed, and
- WHEREAS,** the BIA has instituted a new system (TAAMS) which not only allows the access which once was available through LRIS but also allows for direct input of information, and
- WHEREAS,** the Oneida Tribe has the requisite experience with the data base, the security requirements, the available staff, and the willingness to go through clearance again and the new training, and
- WHEREAS,** the Oneida Tribe would be the first Self-Governance tribe to receive the training and access;
- NOW THEREFORE BE IT RESOLVED,** the Oneida Tribe hereby requests to be a pilot project tribe for the TAAMS access and training, and

**NOW THEREFORE BE IT FURTHER RESOLVED**, the Oneida Tribe hereby commits to assigning staff to receive the clearance and training necessary to access TAAMS, and

**NOW THEREFORE BE IT FURTHER RESOLVED**, the Oneida Tribe hereby commits to pay all connectivity costs for the project.
