#### RESOLUTION # 2-1-95A

- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, the immense growth of the Tribe in the past years has indicated that documents produced by the Tribe may not be kept in a manner to secure them from the general public, and
- WHEREAS, the General Tribal Council wishes to be protected from documents entering the public arena without approval or in cases where confidentiality must be maintained, and
- WHEREAS, there is a need to adopt standard procedures and definitions regarding the use, retrieval, storage and disposal of documents,

NOW THEREFORE BE IT RESOLVED, that the attached Records Management Law is hereby adopted, in accordance with all procedures set out in the Administrative Procedures Act by this body,

NOW THEREFORE BE IT FURTHER RESOLVED, that the existing Records Management Office shall be granted all the authority delegated in Article VI of the attached law and shall be considered the body created by the Article, and

NOW THEREFORE BE IT FURTHER RESOLVED, that this law shall be effective thirty days from adoption, and that the Oneida Compliance Division, or sub-entity thereof, shall be delegated the responsibility to inform the necessary tribal entities of the adoption and procedures within the attached law, and

NOW THEREFORE BE IT FINALLY RESOLVED, that the Records Management Office is directed to work with the Oneida Compliance Division, or sub-entity thereof, to create a manual or other document that adequately informs employees of the Tribe about the procedures of the attached law and any regulations created as a result of this law.

# Statement of Effect Resolution Adopting the Records Management Law Summary

This resolution adopts the Records Management Law. This law governs the use and maintenance of documents created by the Oneida Tribe of Indians of Wisconsin. It directs where documents shall be held and who has the authority to retrieve documents.

#### Analysis

The purpose of this law is to generate procedures for the use and maintenance of documents created in the course of Tribal business and government. All documents, whether confidential or not, are disposed of according to the procedures set out in this law.

Article IV indicates that all documents are considered confidential and need permission of the creator or writer of the document, the person or office that keeps the document, or a person designated as such in an office. However, documents within the control of the Records Management Office shall be maintained and released as directed in Article VI. Article VI also defines levels of confidentiality and who may access those records so defined.

Article V delegates authority to the Human Resources Departments to promulgate regulations, regarding the safekeeping of personnel records. There is also a specific delegation of authority regarding records generated in the course of background investigations in the gaming enterprise.

Article VI delegates authority to a Records Management Office to collect, store and dispose of documents. It further grants the authority to create regulations regarding its duties.

#### Conclusion

There have been the required Public Hearings regarding this law, and it provides necessary protection regarding documents created and maintained by the Oneida Tribe and its entities.
