Office of Juvenile Justice and Delinquency Prevention/FY2009 Tribal Juvenile Accountability Discretionary Grant Program/2009-2012


- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a Treaty Tribe recognized by the laws of the United States, and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS,** the Oneida Business Committee has been delegated the authority under Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS,** the Oneida Tribe of Indians of Wisconsin has determined that the overall goal of the Oneida Nation is to protect, maintain and improve the standard of living and the environment in which the Oneida people live, and
- WHEREAS,** the Oneida Tribe of Indians of Wisconsin recognizes the critical need to address the issues of delinquency, alcohol, drugs, violence and other "at risk" related behaviors which are in direct contrast to the traditions, culture, and spiritual way of life, and
- WHEREAS,** the Oneida Tribe of Indians of Wisconsin believes that our youth, family and community will be strengthened by providing critically needed juvenile accountability-based programming that will have a positive impact on family and youth, health and healing.

NOW, BE IT RESOLVED: that the Oneida Tribe of Indians of Wisconsin will approve the creation and member composition of a tribal advisory board (with by-laws) for the purpose of developing a coordinated enforcement plan for reducing juvenile crime. The approved members of the Oneida Juvenile Accountability Advisory Board for this project are: 1. law enforcement; 2. prosecutor's office; 3. probation services; 4. juvenile (county) court; 5. schools; 6. a local business; 7. cultural; 8. a local non-profit or faith based organization; 9. Oneida Juvenile Services and other members as needed.

NOW, THEREFORE, BE IT FURTHER RESOLVED: that the Oneida Tribe of Indians of Wisconsin in collaboration with the United States Department Justice/Office of Justice Programs/Office of Juvenile Justice and Delinquency Prevention/FY2009 Tribal Juvenile Accountability Discretionary Grant Program, authorizes, submits and endorses the implementation of the "Oneida Continuum of Restoration: Restoring the Fire," for the purposes of securing external monies to strengthen and enhance the need for comprehensive culturally-based juvenile accountability services that addresses the critical needs of our young people both on or near the Oneida Reservation.

CERTIFICATION

GRANT: FY2009 Tribal Juvenile Accountability Discretionary Grant Program

PROGRAM: Oneida Social Services/Youth Services-Juvenile Diversion Program

PROJECT DIRECTOR: Rhonda Toussef

GRANT AMOUNT: \$300,000 over three years.

MATCH: 10% or \$33,000.00 ($\$300,000/0.9 = \$333,333$; $\$333,333 \times 0.1 = \$33,333$ -Required match computation) In-kind match of present program staff, volunteer board, space and other donated costs will cover this match.

SYNOPSIS: A request was received from Alex Lei-Nako, to pursue additional funds for a youth accountability/restorative justice piece. This process will work with a deferred agreement that has been developed within the last four years with the county and school system to bring and keep our youth in our community, if possible. The goal of this program is to keep our youth within our community rather than involving them and usually losing them somewhere within the court and prison system.

The process will also use restorative justice pieces so that youth that are being truant, delinquent or suspended will report in to a Report Center for morning classes for school work and cultural training and youth will do community service for the community in the afternoon. Approval of the advisory board by the governing body is required by funding agency.
