### **RESOLUTION # 02-14-01-A**

#### **Great Lakes Inter-Tribal Council, Inc. Native American Research Centers for Health (NARCH) Proposal**


- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government, a Treaty Tribe recognized by the laws of the United States, and a Self-Governance Tribe with the Departments of Interior-Bureau of Indian Affairs and Health and Human Services-Indian Health Service; and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin; and
- WHEREAS,** the Oneida Business Committee has been delegated authority under Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council; and
- WHEREAS,** it is the mission of the Oneida Nation of Wisconsin to protect and improve the resources, the standards of living, and the provision of primary and public health care services for the Oneida people; and
- WHEREAS,** the Great Lakes Inter-Tribal Council, Inc. (GLITC) submitted an application to NARCH, proposing a partnership with the University of Wisconsin/Madison Medical School for research to assist in determining appropriate prevention and intervention initiatives; and
- WHEREAS,** the Oneida Business Committee recognizes the need for research that is relevant to the Oneida Tribe of Indians of Wisconsin that is appropriate in determining prevention and intervention initiatives for diseases such as diabetes, hypertension, cancer, and heart disease which will ultimately benefit the Oneida people.
- WHEREAS,** the partnership between the Wisconsin Tribes and the University of Wisconsin/Madison Medical School as described in the GLITC proposal will prove to be of great benefit to the respective Tribes.

**NOW THEREFORE BE IT RESOLVED**, that the Oneida Business Committee approves and supports the Oneida Community Health Center's participation in the following GLITC, Inc. proposed research projects:

- 1) The Prevention of Obesity in Wisconsin Native Children
- 2) The Tribal Heart Project
