RESOLUTION # BC-2-14-96-B

WHEREAS. the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty Tribe recognized by the laws of the United States, and WHEREAS. the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the WHEREAS, Oneida Tribal Constitution by the Oneida General Tribal Council, and the Private Sector Initiative Program did not truly respond to the needs of the entrepreneur, and WHEREAS, the community has not been in a financial position prior to this time to allow investment in WHEREAS. individual members who wanted to go into business for themselves, and WHEREAS, the Oneida Business Committee implemented the Oneida Small Business Development Center to replace the Private Sector Initiative for providing small business loans, and the revised Overall Economic Development Plan, the Master Plan, and the Budgeting Process of WHEREAS, the Tribe includes consideration of Oneida Small Business Development Center clients, and

NOW THEREFORE BE IT RESOLVED: that the Oneida Small Business Development Center law will be revised by amending section 4-1 and adding sections 4-5 and 4-6 as follows:

4-1. There shall be created a five four member board whose official name shall be the "Oneida Small Business Development Approval Board," consisting of persons with one or more of the following qualifications:

there is a need to clarify and better organize the Oneida Small Business Development Center.

- a. Accounting
- b. Human Resources
- e. Marketing
- d. Bank Relations
- e. Computers
- f. Business Management

All members shall be from the Oncida Community and a member of the Oncida General Tribal Council. Provided that, where there are insufficient applications for membership on this board, the Director shall be able to choose qualified non-tribal members. Provided further, that all attempts will be made to utilize non-tribal employees for any vacancies on this board. the Assistant General Manager as chairperson, the Enterprise Division Director, and three members from local banks.

4-4. There shall be created a Business Development Review Committee which shall consist of four tribal members whose purpose is to review the presented business. The Business Development Review Committee shall be monitored by the Oneida Small Business Development Approval Board. Further, members of the

Business Development Review Committee shall be appointed by the Oneida Business Committee upon recommendation of the Oneida Small Business Development Approval Board.

4-5. By-laws shall be adopted by the Oneida Business Committee for the Business Development Review Board which may be amended from time to time as needed. Provided that any amendments do not exceed the delegated authority of the Board, and any amendments are approved by the Oneida Business Committee.

Provided further that references to "Oneida Small Business Development Approval Board" throughout the document shall be amended to read "Oneida Small Business Development Approval Board."

NOW THEREFORE BE IT FURTHER RESOLVED: that the intent of creating the Business Development Review Committee is training Tribal members to ultimately be members of the Oneida Small Business Development Approval Board.

BE IT FURTHER RESOLVED: that upon approval of a business loan by the Oneida Small Business Development Approval Board, the Oneida Small Business Development Center shall be responsible to distribute funds after meeting the requirements of the office of the Chief Finance Office. These requirements shall be promulgated by the Chief Financial Officer within a reasonable time after approval of this resolution.

BE IT FURTHER RESOLVED: that the provisions provided herein have been adopted in substantially similar form and have received Public Hearing in that prior form. As a result of those Public Hearings, the amendments presented herein do not constitute sufficient divergence from the original document as to warrant additional Public Hearings and shall be effective upon adoption of this resolution.

NOW THEREFORE BE IT FINALLY RESOLVED: that the Oneida Small Business Development Center Director, Oneida Business Committee liaison, General Manager, and Enterprise Division Director and Chief Financial Officer are hereby directed to continue review of the law and regulations of this entity for further necessary changes to be brought forth within sixty days.
