WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, the Indian Gaming Regulatory Act requires vendors be licensed by the Oneida Tribe of Indians of Wisconsin to conduct Class III gaming business on the Oneida Indian Reservation; and

WHEREAS, the Oneida Tribe/State of Wisconsin Gaming Compact requires gaming vendors be licensed by the Oneida Tribe of Indians of Wisconsin to conduct Class III gaming business on the Oneida Indian Reservation; and

WHEREAS, the Oneida Tribe of Indians of Wisconsin have entered into the attached agreement with Hanson Dist. Company for the purchase of Class III gaming slot machines; and

WHEREAS, the Oneida Tribe of Indians of Wisconsin has conducted a thorough background investigation of Hanson Dist. Company whose address is Suite 1, 9201 Penn Avenue South, Bloomington, Minnesota 55431 pursuant to the Oneida Gaming Ordinance and the Oneida Tribe/State of Wisconsin Gaming Compact; and

WHEREAS, the State of Wisconsin Lottery Board has conducted a thorough background investigation of Hanson Dist. Company and has issued to Hanson Dist. Company a certificate to enter into a gaming related contract involving total consideration exceeding \$10,000 pursuant to the Oneida Tribe/State of Wisconsin Gaming Compact; and
