For the record:	Tina Danforth opposed the motion to cancel the April 21, 2012 meeting, one because we have for several years asked the Secretary's office to find alternative accommodations to have a General Tribal Council meeting because we are outgrowing our meeting space. We have given her that directive, she has followed it, and we took action on it. I think it's important that we accommodate the body versus individual preferences and our sovereignty is not at stake. The Business Committee has made precedence where we have had business committee meetings off reservation, so long as we've had a quorum. We exercise our sovereignty throughout the country at different times, by sending representatives to speak on behalf of the Tribe. That is an exercise of sovereignty which our Chairman and elected officials do all the time.
For the record:	Melinda J. Danforth I do support not having the meeting at Shopko Hall, however I think you're right that the business needs of the Tribe need to be met and that our agenda for July is going to be very full, but therefore I was hoping that we would be able to meet at the Radisson on Monday April 30, 2012 as indicated within the Secretary's memo here as one of the open dates, but motion failed.
For the record:	Ed Delgado stated what we did today is a disservice to General Tribal Council. We're creating a huge agenda for the July meeting, in a very uncomfortable atmosphere. Thank you.
For the record:	Vince DelaRosa stated for the record I support moving in this fashion because I do not want to have a special GTC at a \$198,000 called on this and if we don't address it, there is a petition submitted and they have a right to be heard. I support petitions moving forward so I respect the fact that there is a petition submitted. I understand what the councilwoman said, that we could throw this on another agenda. I'd like to throw this on the very next GTC meeting and I think we should have MIS bring a plan forward, on technology issues. I don't understand why there's no technology component even available to us. That's

very confusing to me. I support for that reason because I don't want a special meeting held and they have a right to have that petition heard.

Greg Matson stated it was my understanding that there was a proposal from MIS or IT specialists to help promote that?

Brandon Stevens stated he would like to thank the committee for reconsidering this issue and allowing the General Tribal Council to have a say in this overall. We represent the General Tribal Council, but this is a major move for the Nation on how we proceed and how we proceed with our meetings and how we have that discussion with them and how we have a voice. Are we are a voice of the 16,000 right now or do we go back to when there's a big question like this, how do we gather that question? I believe sovereignty is always at stake, always at stake. The moment you think its stable, the moment you think you're comfortable with it, that's when somebody's always trying to chip away at it. So I think anything we do or don't do and stand by and watch, that's just distinguishing the sovereignty portion and I think this is what democracy is today. It is allowing voices to be heard, allowing a bigger voice, an audience to happen and I think that's what we'll be doing on the next meeting on having this discussion. Thank you.

Patty Hoeft stated she also wanted to express her thanks to the committee. I think the last meeting we had to decide to go to Shopko Hall was very courageous to take that up and want to try to do that but it appears that the community just isn't ready yet for that kind of a change. So we just need some more time and again as I said we're evolving, but I want to say thank you to all of the committee members because this was a very good discussion today.
