

RESOLUTION No. 3-2-81A

- WHEREAS, the Oneida Tribe of Indians of Wisconsin has received over \$80,000 in grants from the Wisconsin Coastal Management Program during 1979, 1980, and 1981, and
- this assistance from the Wisconsin Coastal Management Program has WHEREAS. resulted in improved management by the Oneida Tribe of Indians of shoreland areas on the Oneida Reservation, and
- WHEREAS, the Wisconsin Coastal Management Program has received significant criticism from government agencies which have boundries that overlap with the Oneida Indian Reservation boundries concerning a shoreland ordinance which was prepared by the Oneida Tribe of Indians with Wisconsin Coastal Management financial assistance, and
- WHEREAS, a function of the Bureau of Indian Affairs Great Lakes Agency, Minneapolis Area Office and the National Office in Washington, D.C., and the Great Lakes Inter-Tribal Council is to support tribal governments,
- Now, Therefore, Be It Resolved, that the BIA National Office, the BIA Minneapolis Area Office, the Great Lakes Agency, and the Great Lakes Inter-Tribal Council write letters of support to the Wisconsin Coastal Management Program commending Coastal Management on their support of the Oneida Tribe of Indians and encourage Coastal Management to continue their support of the Oneida Tribe of Indians in the future, and
- Be It Further Resolved, that this letter be addressed to Mr. George Evenson, Chairman, Wisconsin Coastal Management Council, Department of Administration, 101 South Webster, 7th Floor, Madison, Wisconsin, 53702, and that this letter be copied to U.S. Senator William Proxmire, U.S. Senator Robert Kasten, U.S. Representative Toby Roth, Wisconsin Governor Lee Dreyfus, State Senator Jerome Van Sistine, State Representative Cletus Vanderperren, State Representative Sharon Metz, Brown County Executive Donald Holloway, Green Bay Mayor Sam Halloin, Village of Ashwaubenon President John Monfort, and Oneida Tribal Chairman Purcell Powless.
