BC Resolution # 03-09-16-C Regarding Pardon of Tammy VanDenBloomer


- WHEREAS,** the Oneida Nation is a federally recognized Indian Government and a treaty tribe recognized by the laws of the United States; and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Nation; and
- WHEREAS,** the Oneida Business Committee is delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council; and
- WHEREAS,** the Oneida Pardon and Forgiveness Screening Committee reviewed the pardon application of Tammy VanDenBloomer at a duly called hearing held on February 18, 2016 year); and
- WHEREAS,** the requirements of the Pardon and Forgiveness Law have been fulfilled.

NOW THEREFORE BE IT RESOLVED, that the Oneida Business Committee by this resolution hereby:

- Approves the pardon of Tammy VanDenBloomer for the crime(s) of Theft movable property and notifies the Oneida Tribe of Indians of Wisconsin and its agencies that she is recognized as a member of the Oneida Tribe of Indians of Wisconsin to have all the benefits and opportunities available to all other persons as if the criminal offenses(s) pardoned by this resolution did not exist. The pardon has been approved based on the following:
1. Fulfilled obligations
 2. Finished Counseling
 3. No police contact
 4. Working with the CEC to get GED
 5. 2008 incident isolated
