FISHING RESOLUTION # 9-84-B

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a Treaty Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governmental body of the Oneida Tribe of Indians of Wisconsin. and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Constitution by the Oneida General Tribal Council to protect and preserve the sovereignty of the Oneida Tribe, its rights and its resources, and

WHEREAS, it is the desire of the Oneida Tribe that all enrolled tribal members shall be able to excreise their right to fish for subsistence on the Oneida Reservation, and

WHEREAS, the Oneida Tribe wishes to cooperate with the Wisconsin Department of Natural Resources in identifying the Oneida tribal members exercizing their rights to fish on the Oneida Indian Reservation, and

WHEREAS, the Oneida Tribe further wishes that fishing be regulated in a reasonable and orderly manner, and

WHEREAS, a fishing regulation has been promulgated by the Oneida Business Committee, which provides for regulation of fishing by Tribal members on the Oneida Indian Reservation, a copy of which is attached and incorporated into this resolution.

NOW THEREFORE BE IT RESOLVED, that the attached fishing regulation is hereby a part of the laws of the Oneida Tribe, and shall be enforced as provided by the Oneida Business Committee and the Oneida General Tribal Council.
