


Oneidas bringing several hundred bags of corn to Washington's starving army at Valley Forge, after the colonists had consistently refused to aid them.

For the record by Vince DelaRosa: I oppose the failed motion because we do not make organizational changes based on simple memoranda without adopting Statement of Effects(SOE) or resolutions with an analytical statement on this particular item and because of the impacts of these changes based on that I could not adopt changes that we would enforce without even having the benefit of looking at a resolution or SOE.
