Emergency Adoption of Wild Turkey Season Regulations

- WHEREAS, the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of the Wisconsin, and
- WHEREAS, the General Tribal Council has been delegated the authority of the Constitution of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee may be delegated duties and responsibilities by the Oneida General Tribal Council and is at all times subject to the review powers of the Oneida General Tribal Council, and
- WHEREAS, the Oneida Tribe has adopted a Hunting, Fishing and Trapping Law that identifies the delegated authorities and responsibilities regarding this matter within the Oneida Reservation, and
- WHEREAS, the Environmental Resources Board and Conservation Department have been delegated authority and responsibility for managing the hunting, fishing and trapping seasons within the Oneida Reservation, and
- WHEREAS, it has been determined that the current wild turkey population jeopardizes the growth of the wild turkey population within the Oneida Reservation and surrounding areas such that a wild turkey season is necessary, and
- WHEREAS, it has been determined that failure to hold a wild turkey season would result in reducing the entire wild turkey population or causing damage with the inter-mixing of domestic raised wild turkey carrying potential diseases into the natural population, and
- WHEREAS, it has been determined that this season should coincide with the State of Wisconsin wild turkey season so as to afford the greatest protections for hunters and to accomplish the purposes of authorizing this season to remove the current wild turkey population, and
- WHEREAS, this determination has left insufficient time to allow Public Hearings to be held such that emergency action is necessary to preserve and protect the wildlife under the management of the Environmental Resources Board and the Conservation Department,
- NOW THEREFORE BE IT RESOLVED, that the Oneida Wild Turkey Regulations for 1999 are hereby adopted on an emergency basis for six months and shall be forwarded to Public Hearing, and

NOW THEREFORE BE IT FURTHER RESOLVED, that the Environmental Resources Board and the Conservation Department shall determine at the close of the April/May season if a second season is necessary.
