Melinda J. Danforth, Greg Matson, David Jordan, Paul Ninham, Brandon Stevens Melinda J. Danforth stated many of you should be aware about the Baby Veronica case that's going before the Supreme Court. I had some reservations about the approach that the Tribes were taking but unfortunately those reservations turned into a little bit of joy these last couple of days. Some of the Tribes in different states had gone to the Governor and to the Department of Children and Families and asked them to sign on to our brief to support our position in this case, and some of the States took the opposite position. The Tribes in Wisconsin asked the same and because of the mining issues that are happening I didn't know that it was a good type of environment to bring this request forward, but the Tribes did. So we were successful, and Wisconsin will be signing on to the brief on the side of the Tribes. So that's a very positive movement forward and that outcome of the Baby Veronica case though could have major implications on ICWA, so we will try to keep you involved and the Child Protective Board informed as much as possible.

David Jordan stated I understand where Chaz is coming from. I know my role here is if someone goes through the process of submitting a petition, I could never deny anybody a petition if they follow the right process.

For the record:

Greg Matson stated this is a broad statement. It seems like a direct impact and a direct attack on Seven Gens Corporation which is an avenue that all the Tribal members own, should respect and communicate with. I think this is a direct attack; it seems to be too broad because it states any location within the Oneida Tribal boundaries. It specifically says plastic recycling plant and it's separated out, building any gasification, or waste-to-energy, or plastic recycling plant anywhere within the reservation. It just ties our hands completely with the ability for us to offset what we're being attacked with every day, which is the landfill.

For the record:

Brandon Stevens stated I oppose the motion because I think the petitioner should be afforded a meeting, but May 5th is premature because the board has not made a decision on whether or not they support this project in a location its currently being proposed at. So the cart's before the horse. As far as everything else, I have no opinion on the placement of the proposed site and the location it's being proposed at because we create the institutions of the tribe to vet that process out, to carry those things out. I'm a politician, I'm elected and I create

policy to make sure those institutions are sound. Make sure those due diligences are taking place in the manner that they need to. I'm not an engineer, I'm not a doctor, no PhD, and so I afford myself those opinions on those who are more knowledgeable than me in those areas. I believe the process needs to be taken place, it needs to be followed and then if something like this were to happen, we need to change policy. We need to change a direction on what we want there and make that policy decision rather than a direct decision on trying to stop something that we've not yet had all the information about.
