Oneidas bringing several hundred bags of corn to Washington's starving army at Valley Forge, after the colonists had consistently refused to aid them.

- WHEREAS, the Oneida Pardon Screening Committee has presented a Pardon Petition on behalf of <u>Wyman Skenandore</u>, and
- WHEREAS, the requirements of the Oneida Pardon Ordinance and Oneida Pardon Procedures Policy have been fulfilled, and
- WHEREAS, the Oneida Pardon Screening Committee hereby recommends <u>DENYING</u> the pardon petition of <u>Wyman Skenandore</u>, Petitioner.
