REGARDING PARDON OF JUANITA POWLESS

- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a treaty tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV., Section 1 of the Oneida Tribal Constitution by the Oneida General tribal Council, and
- WHEREAS, the Oneida Pardon Screening Committee has presented a Pardon Petition on behalf of JUANITA POWLESS, and
- WHEREAS, the requirements of the Oneida Pardon Ordinance and Oneida Pardon Procedures Policy have been fulfilled, and
- WHEREAS, the Oneida Pardon Screening Committee hereby recommends <u>APPROVING</u> the pardon petition of <u>JUANITA POWLESS</u>, Petitioner.

NOW THEREFORE BE IT RESOLVED, that the Oneida Business Committee by this resolution hereby:

 \checkmark GRANTS the Pardon of <u>JUANITA POWLESS</u>, Petitioner and notifies the Oneida Nation and its employing agencies that the Petitioner is recognized as a member of the Oneida Nation to have all the benefits and employment opportunities available to all other persons as if the criminal past pardoned by this resolution did not exist.
