RESOLUTION # 3-2/-88-B

- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida General Tribal Council has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, the Oneida Tribal School Board was created by the Oneida General Tribal Council for the purpose of overseeing the operation of the Oneida Tribal School and related educational concerns of the Oneida Tribe, and
- WHEREAS, the responsibilities of the Board have increased since the Oneida Tribal School was opened in 1979, and now include expansion plans and the development of an Oneida High School, and
- WHEREAS, it is in the interest of the Oneida Tribe to share the responsibilities of the Oneida Tribal School Board in the most efficient manner, and
- WHEREAS, increasing the size of the Oneida Tribal School Board from five (5) members to nine (9) will improve the

efficiency of the Oneida Tribal School Board and the education system of the Oneida Tribe.

NOW, THEREFORE, BE IT RESOLVED, that the Oneida Tribal School Board is hereby increased from five (5) to nine (9) members, and that new members shall be elected pursuant to the Oneida Tribal Election Ordinance after a caucus to nominate candidates, said caucus and election to occur after the regular July 1988 Annual Meeting of the Oneida General Tribal Council. The members of the Board shall be installed by oath administered by the Chairman of the Oneida Tribe or his delegate approved by the Oneida Business Committee.
