## BC Resolution 03-26-14-C Extension of the Cemetery Law Emergency Amendments

WHEREAS,	the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by
	the laws of the United States of America, and

WHEREAS.	the Oneida General Tribal Co.	incil is the governing body of the Or	neida Tribe of Indians of Wisconsin, and
WHEREAS,	The Orielua Gerierai Tribai Col	inch is the doverning body of the Or	leida i fide di indians di vvisconsin, and

WHEREAS,	the Oneida Business Committee has been delegated the authority of Article IV, Section 1, of the Oneida Tribal
	Constitution by the Oneida General Tribal Council, and

WHEREAS.	the Cemeter	Law was adopted b	v Resolution BC-05-19-89-E.	and

WHEREAS,	the Cemetery Law allows Tribal members, their spouses, parents and children to be buried in the Tribal cemetery,
	however, other descendants of Tribal members are not eligible to be buried in the Tribal cemetery, and

WHEREAS,	the Cemetery Law restricts who may purchase a burial plot in the Tribal cemetery, even if he or she is purchasing the
	plot for an individual eligible to be buried in the Tribal cemetery, and

WHEREAS,	the Enrollment Department has concerns regarding the re-sale of burial plots that have been purchased for
	individuals who are under the age of eighteen (18) and incompetent individuals who are over the age of eighteen

(18), and

WHEREAS, the Legislative Procedures Act authorizes the Oneida Business Committee to enact legislation on an emergency basis, to be in effect for a period of six (6) months, renewable for an additional six (6) months, and

WHEREAS, through Resolution BC-10-09-13-B, the Oneida Business Committee adopted emergency amendments to the

Cemetery Law, and

whereas, extension of the adoption of the emergency amendments to the Cemetery Law is necessary for the immediate preservation of the public health, safety, or general welfare of the reservation population.

**NOW THEREFORE BE IT RESOLVED,** that the Cemetery Law is amended on an emergency basis for an additional six (6) months as provided in the attached law.

**BE IT FINALLY RESOLVED**, the attached amendments shall be effective upon the expiration of the emergency amendments and shall remain in effect for six (6) months, or until permanent amendments are adopted, whichever occurs first.
