Resolution # <u>3-27-96-A</u>

- WHEREAS, the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of the Wisconsin, and
- WHEREAS the General Tribal Council has been delegated the authority of the Constitution of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee may be delegated duties and responsibilities by the Oneida General Tribal Council and is at all times subject to the review powers of the Oneida General Tribal Council, and
- WHEREAS, the Oneida Business Committee has determined that it is in the best interest of the children of the Oneida Tribe to have persons employed either part-time, full-time, or in charge of children intermittently, to be designated as mandated reporters of child abuse and neglect, and
- WHEREAS, this greatly expands those persons who are mandated reporters within the definition of the State of Wisconsin statutes, and
- WHEREAS, it has been determined that education should precede implementation and enforcement of the Oneida Policy on Reporting Child Abuse and Neglect,

NOW THEREFORE BE IT RESOLVED, that the Oneida Policy on Reporting Child Abuse and Neglect is hereby adopted by the Oneida Business Committee to be implemented 90 days after adoption, and

NOW THEREFORE BE IT FURTHER RESOLVED, that the Oneida Education and Training Department, specifically, Oneida Early Childhood Division and the Career and Development Center, are directed to set-up and make available training sessions within 20 days of adoption of this resolution to allow all applicable employees to receive the required training under this policy,

NOW THEREFORE BE IT FURTHER RESOLVED, that the Human Resources Department, the Principles of the elementary and high schools, supervisors of Early Childhood and Day Care Center areas, and the Director of the Career Center are hereby directed to meet and identify all persons within these and other areas who are responsible as defined in the policy for children during their normal working hours, or as directed within the Wisconsin Statutes and make appropriate scheduling changes to allow these employees to attend the training sessions,

**NOW THEREFORE BE IT FINALLY RESOLVED**, that the Area Manager of Social Services; including any Child Protection Unit are hereby directed to formulate and maintain, with notification to the Career Center, Early Childhood and the Human Resources Department, a form for reporting as directed in this policy.
