RESOLUTION $\sqrt{-2-79-A}$

- WHEREAS, the American Indian Library Service has developed significantly since 1973

 Three factors appear to be responsible for the increase:
 - 1. A growing interest among Tribal leaders and educators
 - 2. The development of training and demonstration programs
 - 3. Continuing support of the Wisconsin Indian Tribal Councils; and
- WHEREAS, the continued use of the University of Wisconsin ETN lies in the fact that each community resident can attend classes in the nearest county courthouse; and,
- WHEREAS, Technical assistance shall be provided to the certified librarians by the Director of the Indian Library Training Program, the Regional Systems Libraries and University of Wisconsin through Wisconsin Department of Public Information and Division of Library Services; and,
- WHEREAS, the certified librarians can now identify, with some degree of assurance, specific factors that are critical to any attempt to meet information needs of the Indian Community; and,
- WHEREAS, over the past few years Indian people and librarians have worked together to establish linkages, identify information needs, demonstrate services and initiate training. The goal of the American Indian Library Service is nationwide implementation with two factors determining whether this goal is attained:
 - 1. The establishment of a national policy commitment, and
 - 2. The development of a continuing and adequate funding base for American Library Service; and
- WHEREAS, the stability of funding and full staff at reasonable salaries is being developed. Once Tribal positions as librarians are acquired academically trained and Wisconsin State Certified Indian Librarians who may be employed elsewhere shall be attracted to Tribal library services;
- WHEREAS, it is proposed that the Certified Librarians will be employed under Balance-of-State, PSE or O-J-T Programs. The use of these type positions will have no effect on local reservation programs of a similiar source.

NOW, THEREFORE, BE IT RESOLVED that the development of other funding sources will be implemented to allow the Indian Libraries to serve as a comprehensive guide to the educational, social, recreational and cultural services available to all the Tribal members on or near the reservations.
