Whereas,

The Oneida Tribe of Indians of Wisconsin, Inc., is responsible for providing and/or facilitating educational opportunities for its tribal members, and,

Whereas,

It is the intent of the Oneida Tribe of Indians of Wisconsin, Inc., to optimally administer and manage all programs directly effecting its membership, and,

Whereas

Public Law 93-638 stipulates that Indian Tribes "are entitled to contract with the Bureau to plan, conduct, and administer all or parts of any program which the Bureau is authorized to administer..." and,

Whereas,

The Self-Determination policy becomes manifest with self-direction and implementation,

Therefore,

Be it resolved that the Oneida Tribe of Indians of Wisconsin, Inc., requests to contract and administer the following BIA contract programs for Fiscal Year 1981 utilizing the Master Contract concept:

1. Higher Education

- 3. Johnson-O'Malley
- 2. Employment Assistance (AVT/DE)
- 4. Graduate Scholarships

BE IT FURTHER RESOLVED, that FY'81 contract negotiations, amendments and/or modifications be initiated through the Oneida Education Director who will seek approval of the Oneida Business Committee.

BE IT FURTHER RESOLVED, that all allocations pertaining to this contract be made available October 1, 1980 via Letter of Credit and that the proposed term of the contract be established as October 1, 1980 to September 30, 1981 with provisions for renewal of the Oneida Master Contract for FY'82, FY'83 and FY'84.

WHEREAS, The Oneida Tribe of Indians of Wisconsin by action of its Business Committee entered into an attorney's contract No. I-l-ind, 42268 dated November 5, 1949, with the law firm of Aaron, Aaron, Schimberg and Hess, for the prosecution of tribal claims against the United States, and the contract was approved by the Commissioner of Indian Affairs on March 8, 1950, for an original term of ten years; and

WHEREAS, Said Contract was therafter extended by the commissioner of Indian Affairs from time to time; and

WHEREAS, Said contract was last extended by the Commissioner of Indian Affairs from March 8, 1975 for an additional term of five years; and

WHEREAS, Said contract expired March 8, 1980 by its own terms; and

WHEREAS, Claims of the tribe pursuant to this contract are now pending before the United States Court of Claims; and

Whereas, It is desirable and in the best interest of the Oneida tribe that said attorneys' contract be terminated,

NOW THEREFORE BE IT RESOLVED, that the Oneida Business Committee, in Session assembled, authorized to act on behalf of the Tribe, hereby terminates and disapproves extending and/or renewing the attorneys' contract with Marvin S. Chapman of the firm of Aaron Schimberg, Hess, Rusnak, Deutch and Gilbert.
