RESOLUTION 4-9-84-A

- WHEREAS, the Oneida Tribal Business Committee is the recognized governing body of the Oneida Indian Tribe of Wisconsin, and,
- WHEREAS, the federal government has recognized the rights of Indian Tribes to have self determination through P.L. 93-638 the Indian Self Determination Act, and,
- WHEREAS, the Oneida Nation has the right and power to enjoy relations with the federal government and State of Wisconsin on a government to government basis, not as a community based organization, and,
- WHERFAS, by designating the Indian Tribes as Community Based Organizations the Governors Employment and Training Office of the State of Wisconsin has failed to meet the intent of the Indian Self Determination Act, and is in violation of section 20.002 (13) of the Wisconsin State Statutues, and,
- WHEREAS, the Wisconsin Governors and Employment and Training Office has failed to respect the sovereignty of the Oneida Nation, and has neglected to meet the job training needs of the Oneida Indian Reservation, and,
- WHERFAS, the failure of the Governors Employment and Training Office to meet the needs of all Wisconsin Reservations and funds committed to provide technical assistance to Wisconsin Indian Tribes is inadequate, and,
- WHEREAS, the Oneida Tribe is deeply concerned for the economic and social welfare of its people, and recognize that joint action by a coalition of Indian Tribes is needed to effect the necessary changes to insure Wisconsin Reservations are adequately served by JTPA programs through the Governors Employment and Training Office,

NOW BE IT RESOLVED, that the Oneida Tribe demands that the Wisconsin Governors Employment and Training Office meets its responsibility to treat the Oneida Nation as a unit of government consistant with P.L. 93-638 and 20.002(13) of the State of Statutues,

BE IT FURTHER RESOLVED, that the Oneida Nation supports the information of a coalition with the Stockbridge-Munsee, Menominee and Wisconsin Winnabago to provide technical assistance to the four Tribes to permit increased participation in job training and economic development. The Chairman of the Oneida Nationalise authorized to begin negotiations with the Stockbridge-Munsee, Menominee and Wisconsin Winnabago to form the coalition.
