BC RESOLUTION 04-11-12-A 2012 Coordinated Tribal Grant Solicitation (CTAS)

- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a Treaty Tribe recognized by the laws of the United States, and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS,** the Oneida Business Committee has been delegated authority under Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS,** the Oneida Tribe of Indians of Wisconsin has determined that the overall goal of the Oneida Tribe is to protect, maintain and improve the standard of living and the environment in which the Oneida people live, and
- WHEREAS,** the Oneida Tribe of Indians of Wisconsin believes that our community will be strengthened by providing critically needed services and programming which will have a positive impact on family, elders and youth health and healing, and
- WHEREAS,** the *Vision* of the Oneida Tribe is to build a Nation of strong families built on Tsi?Niyukwaliho T[^] (Our Ways) and a Strong Economy.

NOW THEREFORE BE IT RESOLVED, that the Oneida Tribe of Indians of Wisconsin authorizes and supports the submission of a FY 2012 Coordinated Tribal Assistance Solicitation grant application to the U.S. Department of Justice for the following purpose areas: #1-Public Safety and Community Policing; # 3- Justice Systems and Alcohol and Substance Abuse; #5-Tribal Sexual Assault Services Program; #6-Violence Against Women Tribal Governments Program; and #10-Tribal Youth Program.
