BC Resolution 04-14-10-C Extension of Amendments to the Parent Policy Leave and Requiring Use of Personal, Vacation, or Flex Time

- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States of America; and
- WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin; and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV of the Oneida Tribal Constitution by the Oneida General Tribal Council; and
- WHEREAS, the budget for Fiscal Years 2010-2012 was adopted by the General Tribal Council on January 17, 2010; and
- WHEREAS, this budget was developed and based on projections of gaming revenues that still may not be realized due to the current economic recession; and
- WHEREAS, under the Parent Leave Policy, the Tribe may pay employees up to four hours of regular scheduled work time, per month, to be used for participation in their children's educational and/or social activities; and
- WHEREAS, BC Resolution 11-12-09-B amended the Parent Leave Policy on an emergency basis to require an employee to take personal or vacation time when taking time off of work to attend their child's educationally sanctioned events; and
- WHEREAS, the Legislative Operating Committee has recommend that the emergency be renewed, with the addition to allow flex time; and
- WHEREAS, the Administrative Procedures Act (APA) authorizes the Oneida Business Committee to enact legislation on an emergency basis, to be in effect for a period of six (6) months, renewable for an additional six (6) months; and
- WHEREAS, emergency adoption of amendments to the Parent Leave Policy requiring the use of personal time, vacation time or flex time is necessary for the preservation of the public health, safety, or general welfare of the reservation population, and that observance of the regular APA adoption requirements for passage of laws would be contrary to public interest.

NOW THEREFORE BE IT RESOLVED, that the following amendment to the Parent Leave Policy/Parent Policy Leave is hereby adopted on an emergency basis:

d. This leave shall not be paid as over-time. <u>An employee may use personal or</u> vacation time to cover this time off, or the supervisor may have the option to use allow flex time to cover this time off to attend their child(ren)'s educationally sanctioned events.

NOW THEREFORE BE IT FINALLY RESOLVED, that this amendment shall be effective through September 30, 2010.
