Norbert Hill moved to adopt the resolution for the lease modification for Franklin Doxtater. Eva Danforth seconded. Motion carried.


Loretta Ellis moved to adopt the resolution for the lease modification for Gary Schuyler. Norbert Hill seconded. Motion carried.

Eva Danforth moved to adopt the resolution for the lease modification for William Schuyler. Norbert Hill seconded. Motion carried.





Bob Christjohn read a resolution for indirect costs. Norbert Hill moved to approve the resolution. Loretta Ellis seconded. Motion carried.
