

WHEREAS, The Oneida Tribal Council has delegated to the Oneida Business Committee authority to exercise the enumerated powers of the Oneida Constitution, Article IV as amended, and

WHEREAS, The Oneida Tribe has acquired in fee status the following parcel described as:

CLARK PROPERTY

A parcel of land, including all of Volume 7 of Certified Survey Maps, page 1283 and other lands located in part of Government Lot 18 and all of Government Lot A, Section 20, Township 24 North, Range 19 East, Town of Oneida, Outagamie County, Wisconsin described as follows:

Commencing at the East One-quarter corner of Section 20, said corner also being the point of beginning; thence South 89°43'06" West along the East-West One Quarter line 1,317.02 feet; thence North 0°03'10" West along the West line of Government Lot A 1,341.80 feet; thence South 89°59'56" East along the North line of Government Lot A and Government Lot 18 a distance of 899.62 feet; thence South 0°00'00" West 208.11 feet; thence South 89°59'56" East 418.62 feet to the East line of Section 20; thence South 0°00'00" West along said East line 1,127.19 feet to the point of beginning, less and excepting that part used and/or conveyed for road purposes.

WHEREAS, The above described parcel is requested in trust status to expand the Oneida Tribal land base and provide a future site for economic development, agriculture, recreation, and residential purposes, and

WHEREAS, The Oneida Business Committe certifies that the local property taxes will be paid up to trust placement, and

NOW, THEREFORE, BE IT RESOLVED, that the Oneida Business Committee hereby requests the United States Bureau of Indian Affairs to initiate and carry out the process required to place the above parcel in trust for the Oneida Tribe of Indians of Wisconsin.
