RESOLUTION NO. 4-21-93-E

WHEREAS, The Oneida Tribal Council has delegated to the Oneida Business Committee authority to exercise the enumerated powers of the Oneida Constitution, Article IV as amended, and

WHEREAS, The Oneida Tribe has acquired in fee status the following parce described as:

## MOOREN PROPERTY

Part of Lots C, 22, 21, 11 and 10, part of the Northwest 1/4 - Southwest 1/4 and part of the Northeast 1/4 - Southwest 1/4, Section 19, T24N-R20E, Town of Hobart, and part of Lots C, 21, and 22, Section 19, T24N-R20E, City of Green Bay, all being in Brown County, Wisconsin, more fully described as follows:

Commencing at the west 1/4 corner, Section 19, T24N-R20E; thence N87°55°57"E, 361.75 feet to the east line of Volume 16, Certified Survey Maps, page 165, Brown County Records, and the point of beginning; thence N2°52'18"W, 101.87 feet along said east line; thence N55045'57"E, 171.45 feet; thence N1020'11"W, 99.00 feet to the south right-of-way of the Green Bay and Western Railroad; thence N55°46'22"E, 850.26 feet along said south right-of-way; thence S2°23'11"E, 132.00 feet; thence S55°46'28"W, 55.88 feet; thence S2°23'11"E, 582.97 feet; thence N87°55'57"E, 47.47 feet along the north line of the Northwest 1/4 - Southwest 1/4, said Section 19; thence N88°34'39"E, 490.73 feet along the north line of the Northeast 1/4 - Southwest 1/4, said Section 19; thence S2049'45"E, 1160.30 feet; thence N88011'49"E, 411.93 feet; thence S2°52'10"E, 618.55 feet to the south line of the North 9 acres of Lot 22, said Section 19; thence S88º13'40"W, 897.85 feet along said south line to the east line of Lot C, said Section 19; thence S3º18'58"E, 14.20 feet along said east line to the southeast corner of said Lot C; thence S88°17'19"W, 1080.82 feet along the south line of said Lot C to the easterly right-of-way of C.T.H. FF, also known as Hillcrest Road; thence 130.50 feet along said right-of-way being the arc of a 1015.37 foot radius curve to the left whose long chord bears N10°17'55"W, 130.41 feet; thence N13°58'50"W, 110.80 feet along said right-of-way; thence N18°47'48"W, 119.10 feet along said right-of-way; thence 352.08 feet along said right-of-way being the arc of a 1859.86 foot radius curve to the right whose long cord bears N8°33°26"W, 351.56 feet; thence N3°08'02"W, 692.08 feet along said right-of-way; thence 52.23 feet along said right-of-way being the arc of a 11409.16 foot radius curve to the right whose long chord bears N2°59'10"W, 52.23 feet to the south line of Volume 16, Certified Survey Maps, page 165, Brown County Records; thence N87°07'42"E, 316.77 feet along said south line; thence N2°52'18"W, 339.52 feet along the east line of said Certified Survey Map, to the north line of the Northwest 1/4 - Southwest 1/4, Section 19, and the point of beginning.

Parcel contains 79.82 acres, more or less.

WHEREAS, The above described parcel is requested in trust status to expand the Oneida Tribal land base and provide a future site for economic development, agriculture, recreation, and residential purposes, and

WHEREAS, The Oneida Business Committe certifies that the local property axes wi be paid up to trust placement, and

NOW, THEREFORE, BE IT RESOLVED, that the Oneida Business Committee hereby requests the United States Bureau of Indian Affairs to initiate and carry out the process required to place the above parcel in trust for the Oneida Tribe of Indians of Wisconsin.
