

Because of the help of this Oneida Chief in comenting a friend-ship between the six nations and the Colony of Pennsylvania, a new nation, the United States was made pos-

- WHEREAS, THE ONEIDA TRIBE HAS FOR THE PAST SEVERAL YEARS ATTEMPTED TO PURCHASE TWO TRACTS OF TRIBALLY ALLOTED LAND, CONSISTING OF 56 ACRES, WHICH ARE KNOWN AS THE JOHN (ALSO LEWIS) AND LEVI DOXTATOR TRACTS, FOR LONG-RANGE DEVELOPMENT PURPOSES AND
- WHEREAS, THE ONEIDA TRIBE HAS BEEN SUCCESSFUL IN PURCHASING FOR \$76,000 THE JOHN (ALSO LEWIS) DOXTATOR TRACT WHILE AT TIME OF PURCHASE TAKING AN OPTION ON THE REMAINING TRACT AND
- WHEREAS, THE ONEIDA TRIBE HAS EXPLORED A VARIETY OF POSSIBLE FUNDING SOURCES WHILE ATTEMPTING TO LOCATE THE HEIRS TO THE REMAINING DOXTATOR TRACT OF LAND AND
- WHEREAS, THE AIRPORT COMMISSION AND OFFICIALS FROM BROWN COUNTY, WISCONSIN WHO HAVE INDICATED IN THEIR LONG RANGE DEVELOPMENT PLANS THAT THE AREA INCLUDED IN THE DOXTATOR TRACTS ARE PRIME COMMERICAL PROPERTY TO BE EVENTUALLY INCLUDED AS PART OF THE AIRPORT COMPLEX AND
- WHEREAS, THE AFORE MENTIONED OFFICIALS HAVE CONDEMNED THE LEVI DOXTATOR TRACT BY EMINENT DOMAIN WHILE THE ONEIDA TRIBE WAS STILL IN THE PROCESS OF RAISING FUNDS TO PURCHASE SAID LAND.
- NOW THEREFORE BE IT RESOLVED THAT THE ONEIDA TRIBE REQUEST SENATOR JAMES ABOUREZK AND HIS STAFF TO INVESTIGATE THE CIRCUMSTANCES UNDER WHICH OFFICALS OF BROWN COUNTY, WISCONSIN SAW FIT TO CONDEMN INDIAN ALLOCATED LAND AS DESCRIBED IN THIS RESOLUTION.
