## **RESOLUTION NO. 5-04-05-AA** Fee to Trust Resolution for the Former Robert Vander Perren Property WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a Treaty Tribe recognized by the laws of the United States, and WHEREAS. the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and WHEREAS, the Oneida Business Committee has be delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and WHEREAS, the Oneida Tribe has acquired in fee status the following parcel described as: Former Robert Vander Perren Property located at 3781 Hillcrest Drive in the Village of Hobart WHEREAS, the parcel is described as follows: The following land contains 6.792 acres more or less, being more particularly described as: Lot Two (2), Volume 18 Certified Survey Maps, Page 97, said map being part of Government Lots One (1) and Two (2), Section Twenty-five (25), Township Twenty-four (24) North, Range Nineteen (19) East of the Fourth Principal Meridian, in the Town of Hobart, Brown County, Wisconsin Tax Parcel No. HB-746-2 the above described parcel is requested in Trust Status to expand Oneida Tribal land base and provide an WHEREAS, existing site for a residential house, and WHEREAS. the Oneida Business Committee certifies that the local property taxes will be paid up to trust placement, and

NOW THEREFORE, BE IT RESOLVED, that the Oneida Business Committee hereby requests that the United States Bureau

of Indian Affairs to initiate and carry out the process required to place the above parcels in trust for the Oneida Tribe of Indians of Wisconsin.
